# **Neighborhood Watch Committee**

- 1. Celeste Akkad showed us the Neighborhood Watch sign that we ordered. After the purchase of a 12' tall wood post, it will be installed in an area above the entrance to the right of Carmel Knolls Drive.
- 2. Celeste Akkad gave Valerie Hunken the literature that was included with the sign regarding neighborhood watch guidelines.

1. A discussion ensued regarding a summer gathering of Knolls residents. It was decided that we would have a bratwurst and beer party in the Partridge Place cul-de-sac July  $16^{th}$ .
